Prior to starting the paperless permit application, it is highly recommended that the applicant gathers the items listed below.

	Provide elevations of stairs
	Provide architectural stair details. Include the stairway width, tread and riser, landing, handrail dimensions, handrail extension and return, walking surface, etc. [CBC 1011]
	For enclosed decks, provide ventilation calculations on the plans showing the net free cross ventilation area is not less than 1/150 of the area of each separate space within the deck. [CBC 2304.12.2.6]
Deck Section: Specify type of naturally durable wood or preservative treatment for supporting members (beams and posts). [CBC 2304.12.2.5]	
SUPPORTING DOCUMENTS	Provide structural calculations, stamped, and signed by a licensed professional, showing the deck members can support the required loads. Live load is 1.5 times the required LL, not to exceed 100PSF
	Provide specifications and installation instructions for the deck waterproofing. [CBC 2304.12.2.5]
