SMOKE ALARMS

Health & Safety Code § 13113.7 (d) (1) The owner shall be responsible for testing and maintaining alarms in hotels, motels, lodging houses, apartment complexes, and other multiple-dwelling complexes in which units are neither rented or leased.

California Fire Code § 907.2.11.2 requires that single or multiple-station smoke alarms be installed and maintained in all residences at all of the following locations:

- 1. On the ceiling or wall outside of each separate sleeping area in the immediate vicinity of bedrooms.
- 2. In each room used for sleeping purposes. (Required for all rental units on or before January 1, 2016)
- 3. In each story within a dwelling unit, including basements but not including crawl spaces and uninhabitable attics. In dwellings or dwelling units with split levels and without an intervening door between the adjacent levels, a smoke alarm installed on the upper level shall suffice for the adjacent lower level provided that the lower level is less than one full story below the upper level.

CARBON MONOXIDE ALARMS

Health & Safety Code § 17926. (a) An owner of a dwelling unit intended for human occupancy shall install a carbon monoxide device, approved and listed by the State Fire Marshal pursuant to Section 13263, in each existing dwelling unit having a fossil fuel burning heater or appliance, fireplace, or an attached garage, within the earliest applicable time for all other existing dwelling units intended for human occupancy

California Fire Code § 1103.9 Carbon monoxide alarms. Existing Group I or R occupancies located in a building containing a fuel-burning appliance or a building which has an attached garage shall be equipped with single-station carbon monoxide alarms.

Exception: Sleeping units or dwelling units which do not themselves contain a fuel-burning appliance or an garage, but which are located in a building with a fuel-burning appliance or an attached garage, need not be equipped with single-station carbon monoxide alarms provided that:

1. The sleeping unit or dwelling unit is located more than one story above or below any story that contains a fuel-burning appliance or an attached garage;

2. The sleeping unit or dwelling unit is not connected by duct work or ventilation shafts to any room containing a fuel-burning appliance or to an attached garage; and

3. The building is provided with a common area carbon monoxide alarm system

FIRE EXTINGUISHERS


California Fire Code 906.1 Exception: Group R-2 occupancies may provide a portable fire extinguisher with a minimum rating of 1-A:10-B:C in each dwelling unit, in lieu installation of 2-A: 10-B:C extinguishers in common areas that are susceptible to vandalism.

As owner/agent of the above referenced property, I hereby certify that the smoke/carbon monoxide alarm and fire extinguishers have been installed in accordance with the manufacturer's instructions and in compliance with the code sections referenced above.




SAMPLE RESIDENTIAL FLOORPLAN













SPLIT HALLWAY
