

8. During your scheduled visit to the Permit Center for review and approval of your plans and project the City staff will go over your stormwater requirements (NPDES, BMP's, SWPPP's). In addition you may receive the 'Contractors Best Management Practices' brochure. When your project is approved you will receive further information during your pre-construction meeting. In addition you may schedule a field meeting to go over the installation requirements as per your approved plans. During the construction phase of your project you will receive a letter around the end of September or early October regarding your BMP and SWPPP's requirements in preparation for winter. However, the City of Salinas requires BMP's and SWPPP's all year and you will receive weekly inspections for compliance.

The Permit Center staff is here to assist you in your efforts to comply with the requirements of both the State of California and the City of Salinas. Some of the links provided in this brochure should apply throughout the County of Monterey.
