- (2) Direct staff to prepare a **RESOLUTION** calling an election to ask the voters of the City of Salinas to modernize the Utility Users Tax within the City of Salinas by reducing the applicable tax rate and updating the applicability of the Utility Users Tax; and
- (3) Direct staff to prepare a **RESOLUTION** requesting that the Monterey County Board of Supervisors consolidate the election with the established general election to be held on November 4, 2014, and requesting the Monterey County Elections Department to conduct the election on the City's behalf.

The City Council will recess to closed session pursuant to:
